Event Waiver of Liability and Release

I acknowledge that participation in the CREDA Downtown Denver Fun Run/Walk is a potentially hazardous activity. I certify that I am medically able to participate and assume full responsibility for my participation.

I knowingly and voluntarily assume all risks, whether known or unknown, foreseeable or unforeseeable, arising from my participation in this event, including but not limited to: falls; contact with other participants or members of the public; weather conditions; traffic; trail or surface conditions; encounters with animals; injuries, illness or death.

I understand that Denver is known as the "Mile High City" due to its elevation of approximately 5,280 feet, and that participants who are not acclimated to this altitude may experience symptoms such as shortness of breath, dizziness, fatigue, or altitude sickness, particularly during physical exertion. I am aware of this risk and will take appropriate precautions, such as staying hydrated and pacing myself accordingly.

In consideration of being permitted to participate, I waive, release, and discharge, to the fullest extent permitted by law, CREDA, the CREDA Conference, Go! Running Tours, the City of Denver, all Event sponsors, and their respective officers, directors, employees, agents, representatives, volunteers, contractors, and affiliates (collectively, the "Released Parties") from any and all claims, demands, damages, losses, actions, or liabilities arising out of or related to my participation in the Event, including those resulting from the negligence of the Released Parties, to the fullest extent permitted by applicable law.

I agree to comply with all Event rules and instructions, to follow the directions of Event organizers and Go! Running Tours guides, and to obey all applicable traffic laws and pedestrian signals during the Event. I understand that bicycles, strollers, skateboards, skates, pets, and personal music players are not permitted.
